- Lawrence Building leak in HVAC chiller stopped. Lease for National Disc Golf Association being developed for warehouse space
- License to evaluate Steam Plant facility for use as data center granted
- Assisting Garrisons for Veterans in obtaining license from DBHDD to evaluate Boone Building
- Flock security cameras being installed on campus
- Grove Events Center M Day event held 5 other events scheduled before end of year
- Kitchen project lease being reviewed by Byline Bank. Some repairs being done in anticipation of reopening facility
- Last fiscal year audit is complete. Auditor to be present at January meeting
